PROJECT STAFF LED 19 NEW RESTORATION PROJECTS IN 2019 INCLUDING IN-STREAM WORK, LARGE WOODY DEBRIS (LWD) PLACEMENT, FISH PASSAGE BARRIER REMOVAL, AND LIVESTOCK EXCLUSION.
